### Residential Care

#### *Fees and Charges Guide*

The government is responsible for setting the fee structures for all aged care facilities; they regulate consumer fees and charges for residential aged care. Please find below information relating to the various fees and charges associated with permanent residential aged care as well as respite care at Tabulam & Templer Homes for the Aged (TTHA).

#### Admission into Tabulam and Templer Homes for the Aged (Wait List)

TTHA requires the following information and documents to be admitted into aged care:

1. A valid aged care assessment is required.
2. An aged care application form.
3. A means-tested care fee was assessed by Centrelink.
4. Legal Documentation (see p.4)

#### 1. Aged Care Assessment

- a. A valid Aged Care Assessment is required to enter Aged Care.
- b. The **Aged Care Assessment Team** (ACAT) will approve your eligibility for access to residential permanent or respite aged care.
- c. The ACAT assessment is a free, government funded service.

## How much will it cost to enter an aged care home?


The Australian Government pays for some of the services provided in aged care homes by way of subsidies for each consumer, paid directly to the aged care home, but you'll also be required to contribute to the cost of your care.

How much you do pay (in addition to the standard Basic Daily Care Fee that everyone pays) is means-tested and depends on your financial circumstances.

### What are the costs?

There are different types of care fees in residential permanent care. Please find the fees as of 1<sup>st</sup> July 2023 in the table below.

| <p><b>Basic Daily Care Fee</b></p>  | <p>This is a daily care fee, set by the Government that is paid by all consumers – Permanent &amp; Respite, regardless of income or assets level, to assist with the costs of daily living as meals, cleaning, laundry and heating.</p> <p>It is set at 85% of the single basic aged pension and is subject to review every six months by the Department of Social Services. The fee is currently <b>\$60.86</b> per day (as of 20<sup>th</sup> September 2023).</p>  |
| <p><b>Means Tested Care Fee</b></p> | <p>This is a daily fee determined by the Government, based on your income and asset assessments, to further contribute to your day-to-day care costs.</p> <p>There are annual and lifetime caps that apply to the Means Tested Care Fee. <i>(Any Income Tested Care Fee paid on a Home Care Package will also count towards your annual and lifetime caps).</i></p> <p>To get an estimate of your Means-Tested Fee, call My Aged Care on <b>1800 200 422</b> or the DHS has developed a useful online calculator on their My Aged Care website at: <a href="http://www.myagedcare.gov.au/fee-estimator/residential-care/form">http://www.myagedcare.gov.au/fee-estimator/residential-care/form</a>. You will need to have all your financial information ready though, especially details of your various forms of income and assets.</p> |
| <p><b>Accommodation Fee</b></p>     | <p>Every room at a care home has a price that is based upon the room type and its features. If you're a non-concessional consumer, you can choose to pay your accommodation fee by either:</p> <ul style="list-style-type: none"> <li>• A lump sum – Refundable Accommodation Deposit (RAD)</li> <li>• A daily charge – Daily Accommodation Payment (DAP)</li> <li>• Or a combination of both RAD and DAP</li> </ul> <p>This gives the consumer choice and flexibility.</p>   |

|   |  <p><b>Refundable Accommodation Deposit (RAD)</b><br/>This is a lump sum (the room price) that is fully refundable when you leave.</p> <p><b>Daily Accommodation Payment (DAP)</b><br/>This is a daily payment of interest on the room price. The DHS sets the Maximum Permissible Interest Rate (MPIR) that you pay.</p> <p><b>A combination of both RAD and DAP</b><br/>You can choose to pay part of your RAD, and a DAP on the remaining amount.</p> <p><b>RAD</b> - A Refundable Accommodation Deposit is a lump sum amount of money paid or payable by a consumer for entry to residential care that is fully refundable to the consumer or their estate on termination of the agreement for residential services, and is Government guaranteed.</p> <p><b>DAP</b> - This is a daily payment of interest on the room price. The DHS sets the Maximum Permissible Interest Rate (MPIR) that you pay. The current MPIR is 8.15% as of 1<sup>st</sup> July 2023.</p> <p>(Calculations, room prices and payment options are provided on the last page as examples. You have 28 days from the date of admission to decide how you wish to pay your Accommodation Fee.)</p> |
| <p><b>Additional Services Fee</b></p>                                     | <p>Additional Services Fee of <b>\$20<sup>1</sup></b> per day for our new Sarona Wing* and <b>\$10<sup>1</sup></b> for all other areas to actively improve the wellness of our consumers. This includes:</p> <ul style="list-style-type: none"> <li>• Spacious Rooms</li> <li>• Great choice of food</li> <li>• Snack Bar</li> <li>• Weekly Happy Hour</li> <li>• Alcoholic beverages (beer or wine)</li> <li>• Soft Drinks</li> <li>• Telephone connection</li> <li>• WI-FI connection</li> <li>• In-room smart TV*</li> <li>• King single bed*</li> <li>• Shopping Assistance</li> <li>• Bus Outings (drive only)</li> <li>• Mobile library service</li> </ul>  |
| <p><b>Other Services Offered</b></p> <p><i>Additional costs apply</i></p> | <p>TTHA offers other services at extra cost. | <b>How are fees charged?</b>                 | Fees are charged monthly in arrears by direct debit. Consumers will be asked to sign a direct debit authority when accepting the offer of a place at TTHA. Fees and charges are subject to change.  |
| <b>Consumers with Low Means</b>              | <p>In assessing fees and charges payable, a concessional consumer is a consumer who is eligible for a full or partial accommodation supplement from the Australian Government. For low means consumers, the Government will contribute to the cost of the accommodation.</p> <p>All consumers will need to complete a Residential Aged Care Calculation of your cost of care form which is a means test assessment and will be used to determine what you will pay in residential aged care. | <b>Respite Fee</b><br><i>Short term stay</i> | Consumers in respite care pay the Basic Daily Care Fee of <b>\$60.86</b> per day plus a booking fee of <b>\$150.00</b> per stay. Respite fees are invoiced in advance and must be paid before admission. Respite stays will incur the applicable additional services fee.   |

## Legal Documentation

- a. It is advised that all consumers have the below legal documentation completed before entering residential care:
  - i. Power of Attorney – Financial and Medical
